Bid Opening Meeting

The trustees of Scioto Township met in special session on Wednesday, February 7, 2018 at 7:00 p.m. at the Scioto Township Community Center 3737 Ostrander Road, Ostrander, OH 43061. Board members present were Ralph Moseley, Sandra Stults, and Doug Loudenslager. Others in attendance are listed on the attached sign-in sheet.

Bid packages turned in: Ohio Groundskeeping LLC at \$2580.00/per mow and trim. Property Worx at \$4,440.00/per mow and trim. Ostrander Implement at \$1,085.00/ per mow and trim. Pony Lawncare and Landscaping at \$815.48/per mow and trim.

REGULAR MEETING PROCEEDINGS SUMMARY:

The trustees of Scioto Township met in regular session, Wednesday, February 7, 2018 at 7:00 p.m. at the Scioto Township Community Center, 3737 Ostrander Road, Ostrander, Ohio 43061. Board members present were Ralph Moseley, Sandra Stults, and Doug Loudenslager. Also present was Fiscal Officer, Kathy Melvin, Fire Chief, Marvin McIntire, and Zoning Inspector Dan Quick. Others in attendance are listed on the attached sign-in sheet.

Chairman Stults called the meeting to order at 7:05 pm with the pledge of allegiance.

GUEST ACKNOWLEDGEMENTS:

Doug Riedel, Delaware County

Update of Stover Road. The OPWC grant was not awarded to Scioto Township. He stated do not be discouraged as there are more applications than funds. Scioto Township was awarded monies for Klondike Road in 2017.

Trustee Moseley has added Stover Road as maybe grader patch areas and reapply for 2019. Doug suggested get the REA's and these roads are dependent upon costs. Bob Sears will help with spending the township funds frugally with the list of roads provided.

Material bids have been opened however; the asphalt bids are not open yet.

Trustee Moseley is working to stockpile fill for future roadwork.

The culvert on Stover Road easements are not prepared yet but Doug hopes to have them very soon. Doug suggests the Township call, meet the residents, and let them know the extent of the project. There would be 2 residents the township will need to reach out to regarding this project.

Jennifer William from the Health Department

Jennifer was here to speak regarding the DKMM solid waste district and work on the recycling and illegal dumping. They work with the juvenile court to get help with larger pick up items the trash and litter debris. New brochures are up on the health district web site. There are special collection events that county residents may participate.

They are working on getting A frame signage that are interchangeable to help address illegal dumping.

There was much discussion amongst the Trustees and Jennifer on what can and cannot be recycled and what to do with the items that cannot be recycled.

Emily Jesson and Corinne, a health nurse from Delaware County, will be sharing the Scioto Township meeting responsibilities.

Trustee Moseley asked the Health Department to help with a property on the corner of Penn Road and 257. Zoning Inspector stated Doug Sams is working with the Township.

BOARD COMMENTS:

There is still clean up on Fish Road where the truck went into the ditch during a snow storm. The Trustees and maintenance workers are aware of this cleanup and will get to this as soon as they can. Trustee Loudenslager asked if we should contact MillCreek Township and make them aware. Trustee Moseley will contact Millcreek.

Trustee Stults has a concern with Pony Lawncare and Landscape due to lack of cemetery work. The bid for Pony was \$815.48 per mow and trim.

The next lowest bid was Ostrander Implement and it was \$1,085.00 per mow and trim.

The next bid was Ohio Groundskeeping LLC with \$2,580.00 per mow and trim.

Trustee Loudenslager appreciates the past business of Ostrander Implement and the job they have done. Trustee Loudenslager has a concern with the amount of jobs Pony Lanwncare and Landscaping has and if the Township will received the attention needed.

There were more questions directed to Pony Lawncare and Landscaping from the trustees that were more individualized and concerns brought up about timing, wetness, and crew numbers.

Trustee Moseley motioned to award the 2018 and 2019 mowing bid for Scioto Township to Pony Lawncare and Landscaping for a cost of \$815.48 per mow and trim provided results from references check out. Trustee Stults will make the reference calls. The motion was seconded by Trustee Loudenslager. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes and Mr. Loudenslager-abstain. The motion passed with 3-yes and 0-no votes.

Trustee Moseley moved to accept the minutes of the January 3, 2018, as presented by the Fiscal Officer with the mentioned changes to page 4 and page 6. The motion was seconded by Trustee Loudenslager. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes and Mr. Loudenslager-abstain. The motion passed with 3-yes and 0-no votes.
