SCIOTO TOWNSHIP TRUSTEES RECORDING OF PROCEEDINGS May 2, 2018

REGULAR MEETING PROCEEDINGS SUMMARY:

The trustees of Scioto Township met in regular session, Wednesday, May 2, 2018 at 7:00 p.m. at the Scioto Township Community Center, 3737 Ostrander Road, Ostrander, Ohio 43061. Board members present were Ralph Moseley, Sandra Stults, and Doug Loudenslager. Also present was Fiscal Officer, Kathy Melvin, Fire Chief, Marvin McIntire, and Zoning Inspector Dan Quick. Others in attendance are listed on the attached sign-in sheet.

Chairman Stults called the meeting to order at 7:01 pm with the pledge of allegiance.

GUEST ACKNOWLEDGEMENTS:

Doug Riedel, Delaware County Doug was able to give an update on Stover Road and the culvert pipe is set and looks good. They are making good process and have not run into any snags at this time.

Trustee Loudenslager asked Doug about the new dump trucks running at the Stover Road site when not in use and what the County's practice. Doug Riedel is not sure but will get back to Trustee Loudenslager.

Trustees will submit REA requests for Jacktown Road and Stover Road (2nd culvert) and the OPWC Grant information for Stover Road to Doug Riedel.

Doug Riedel suggested OPS on Warren Road to verify what underground lines are there. This will save some time. There shouldn't be an issue squeezing this job in between other county jobs.

There were questions about software/GPS for tracking culverts. Doug Riedel stated the County has a program and they are willing to share that with the Townships.

Trustee Moseley also suggested the grader patching quotes for Carr Road and Burnt Pond from 36 to Stults Farm.

Health Department

Mosquito trapping to start Monday. The Data Release from the Community Health Assessment is May 22, 2018 at Ohio Wesleyan and RSVP is needed.

Mr. Dan Inkrot Klondike Road was present to ask about wires down from culvert install and old wire fence. He spoke with Doug Riedel and Doug took down his information. The fence is possibly owned by the quarry and Dan will be in touch with the quarry to inquire about the fence.

Stephanie Vonderwell 257 S resident inquired about 257 updates if any regarding the speed, signage and straightening of the road. Trustee Stults reported that she has been informed that the state will be considering those changes when the road is repayed in 2019.

BOARD COMMENTS:

Trustee Moseley stated Slocum Road is going to need the ditches cleaned out and he will have the maintenance guys work on this now the weather is better.

Trustee Loudenslager has been approached by Schindlewolf regarding water in his basement and the utility box is on his property. Schindlewolf will be contacting Soil and Water to come and evaluate the drainage.

Trustee Moseley will write a letter for resident Ed Roberts who had a tree cut down that was in the road right of way using this as a donation to the Township.

Trustee Stults stated the park ball diamonds are full during the week and the only opening are on the weekends. Please schedule diamond time with Trustee Stults.

Trustee Stults prepared Thank you notes for Testa Trucking and KLM in appreciation in the work relationship they have with the Township and Community.

Trustee Stults replied by email and phone call to Isaac Wiles and their records request regarding Ostrander Road and 36.

Trustee Moseley will reserve the room to turn off the water to replace the valves.

Trustee Moseley will have the park shelter house roofs evaluated for repaired or replaced.

Trustee Moseley asked about the voting equipment drop off due the room being occupied this weekend. Fiscal Officer Kathy will contact the county to drop off equipment on Monday, May 7, 2018.

Trustee Stults moved to accept the minutes of the April 4, 2018, as presented by the Fiscal Officer. The motion was seconded by Trustee Moseley. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

Trustee Loudenslager also stated the Reichert Farm will be scheduling zoning meeting with the Village in anticipation of annexation into the Village of Ostrander. That meeting is scheduled for June 14th.

Fiscal Officer to find out from UAN regarding reimbursements on the paychecks and can this be done without being taxed and without changing their taxing status.
