REGULAR MEETING PROCEEDINGS SUMMARY:

The trustees of Scioto Township met in regular session, Wednesday, August 1, 2018 at 7:00 p.m. at the Scioto Township Community Center, 3737 Ostrander Road, Ostrander, Ohio 43061. Board members present were Ralph Moseley and Sandra Stults. Doug Loudenslager is absent. Also present was Fiscal Officer, Kathy Melvin, Fire Chief, Marvin McIntire, and Zoning Inspector Dan Quick. Others in attendance are listed on the attached sign-in sheet.

Chairman Stults called the meeting to order at 7:04 pm with the pledge of allegiance.

GUEST ACKNOWLEDGEMENTS:

Health Department Korin Reed from the DCHD presented the trustees with Farmers Market and using food stamps. Also a pamphlet about the 8th Annual Suicide Prevention Walk.

Doug Riedel, DCEO, spoke on the culverts will not be completed before school starts.

The study of the roads and signage is being done by the County. They haven't decided how and who will be responsible for the signage, whether it is left up to township officials or the county pools the townships and a contractor. The deadline is the end of December 2019. The purpose is to verify the signs are correct with the mph and if they are in the correct places or if more would be required.

OPWC application for Stover Road. There would need to be 2 resolutions to be signed. Authorizing Legislation by Scioto Township for Stover Road Improvements Project (see attached Resolution). Cooperation Agreement between Scioto Township and Delaware County for Stover Road Improvements Project (See attached Agreement).

There was more talk about the road levy.

Erik Leber was present and shared his thoughts and layout for the car show being held at the township on September 15, 2018 from 1 to 5. Registration starts at 11am and ends with awards around 4:15pm.

He asked if handicap spaces need to be left open this day during the car show. This will need to be discussed with the proper authority. Looking to have 60-70 cars.

Erik to have volunteers driving people back and forth for the attendees parking at school lot.

Parking for the car show visitors park at the school or the grassy area at the township hall (depending on weather)

Sponsors are allowed a popup tent

Stage to be in the corner and Kelly Ryan will play music and make announcements.

Possible prizes and auction items and trophies will be on the stage.

Trash cans and cleanup will be done by Erik and his volunteers.

Vendors will be food trucks, sponsors, information booth.

\$2 million bond from Erik – provided with the Township Rental Agreement

Signed Rental Agreement and payments along with copy of bond will be turned in prior to event.

No roadways will be blocked.

Estimated 1000 plus

Restrooms can be provided (port-a-pot)

Cones out for walkers coming from school grounds (non-participant meeting) If Village wants the \$25 permit fee Erik will pay that fee.

The roll call vote: Ms. Stults-yes, Mr. Moseley-yes and Mr. Loudenslager-absent. The motion passed with 2-yes and 0-no votes.

Trustee Stults asked about fair and the fire department schedule.
