SCIOTO TOWNSHIP TRUSTEES RECORDING OF PROCEEDINGS JUNE 16, 2021

REGULAR MEETING PROCEEDINGS SUMMARY:

The trustees of Scioto Township met in regular session, Wednesday, June 16, 2021 at 5:30 pm via Go To Meeting video conferencing and in person at the Township Hall. Board members present were Ralph Moseley, Sandra Stults, and Doug Loudenslager. Also present was Fiscal Officer, Kathy Melvin. Chief McIntire and Zoning Inspector Herb Ligocki were absent. Resident Don Tebo was in attendance via video.

APPROVAL OF MINUTES:

Trustee Moseley moved to accept the minutes of the June 2, 2021, as presented by the Fiscal Officer. The motion was seconded by Trustee Loudenslager. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

Information on Contractors for Road Work

 CDK Structures Inc. estimate covering culverts on Calhoun, Shipley, Degood, and Fry Roads. The Township will provide asphalt with CDK providing labor of rolling the asphalt.

Trustee Loudenslager moved to accept CDK Structures, Inc estimate for culvert work. The cost not to exceed \$13,811. This cost will come from Roads & Bridges 2031-330-360-003. The motion was seconded by Trustee Moseley. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults asked if parking at the Township Hall for the July 3 parade and ride their float into town. There were no issues provided they were there earlier enough and did not block bay doors or other traffic.

Other culvert work updates are Smart and Fontanelle Roads are a county expense. The township will be responsible for part of Jacktown Road grader patch at a cost of \$5,400. Trustees requested that this is part of the county grader patch schedule.

Trustee Loudenslager made a motion to pay bills. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.
