PUBLIC COMMENT:

• Doug Riedel, Delaware County Engineer Office, was present to discuss OPWC grant for Russell Road and obtain signed resolution to move forward.

Trustee Loudenslager moved to approve Resolution 10-20-2021-01 Cooperative Project Agreement with Concord Township on the Russell Road Improvements Project and authorizing Trustee Moseley as signatory for the township. - Trustee Moseley asked about guardrail on Klondike Road near quarry.
 - Resident has been backfilling the area and would like to know if the guardrail could be removed.
 - o Doug Riedel stated have resident finish the work, then the township verifies the work and then submit REA asking if the guardrail could be removed.
