WHEREAS, the Delaware County Engineer is requesting the Board of Trustees to consider the adoption of a Resolution to request the Ohio Department of Transportation to lower the speed limit for Russell Road (TR 161) between Township Line and Penn Road (CR 158); and

WHEREAS, Russell Road (TR 161) between Township Line and Penn Road (CR 158) is currently 55 mph; and

WHEREAS, in order to provide a consistent speed limit to the traveling public, it has been determined that the Ohio Department of Transportation will consider a 45 mph speed limit for that portion of the roadway; and


WHEREAS, the Delaware County Engineer is recommending that the Board of Trustees pass a Resolution to request the Director of the Ohio Department of Transportation to determine and declare a 45 mph speed limit for that portion of Russell Road (TR 161) between Township Line and Penn Road (CR 158) located in Scioto Township.

Section 1. The Board of Trustees hereby requests that the Director of the Ohio Department of Transportation determine and declare a 45 mph speed limit for Russell Road (TR 161) between Township Line and Penn Road (CR 158).

Section 2. Upon being advised that the Director of the Ohio Department of Transportation has determined and declared a revision of the speed limit on the section of the road described above, the Board of Trustees shall promptly erect standard signs properly posted and giving notice thereof,
