PREAMBLE

WHEREAS, the Board is in need of additional revenue to meet and pay costs and expenses associated with the projects, purchases, and authorized purposes listed in R.C. § 4504.18 and as such statute and list may, from time to time, be amended, supplemented, and/or changed; and,

WHEREAS, R.C. § 4504.18 authorizes a board of township trustees to levy an annual license tax, in addition to the tax levied by R.C. §§ 4503.02, 4503.07, and any other tax levied under Chapter 4504, upon the operation of motor vehicles on the public roads and highways in the unincorporated territory of the township; and,

WHEREAS, the Board, to satisfy the above specified need for additional revenue, desires to levy the annual license tax as authorized by R.C. § 4504.18 at the rate of five dollars and zero cents (\$5.00) per motor vehicle on all motor vehicles the owners of which reside in the registration district known as the unincorporated area of Scioto Township, Delaware County, Ohio ("Township"); and,

WHEREAS, prior to the adoption of this Resolution imposing such tax and in accordance with R.C. § 4504.18, the Board conducted two (2) public hearings on this Resolution and the annual license tax to be levied by this Resolution; the hearings being held on June 19, 2024 and June 24, 2024, the second hearing being not less than three (3) nor more than ten (10) days after the first. Notice of the date, time, and place of such hearings was published in the Delaware Gazette, a newspaper of general circulation in the Township, once a week on the same day of the week for two (2) consecutive weeks, the

- 1. Pursuant to R.C. § 4504.18, an annual license tax is levied upon the operation of motor vehicles on the public roads and highways in the registration district known as the unincorporated area of Scioto Township, Delaware County, Ohio.
- 2. Such tax shall be levied at the rate of five dollars and zero cents (\$5.00) per motor vehicle on all motor vehicles the owners of which reside in the registration district known as the unincorporated area of Scioto Township, Delaware County, Ohio.
- 3. The intent of this Resolution is to levy the full tax a township is allowed to annually levy under R.C. § 4504.18.
- 4. All revenues realized from the tax levied pursuant to this Resolution shall only be used to meet and pay costs and expenses associated with the projects, purchases, and authorized purposes listed in R.C. § 4504.18 and as such statute and list may, from time to time, be amended, supplemented, and/or changed.
- 5. All appropriate state, county, and local officials are authorized and shall enforce this Resolution.
- 6. The annual license tax enacted by this Resolution shall be effective and begin on January 1, 2025.
- 7. The Scioto Township Fiscal Officer is authorized and, pursuant to R.C. § 4504.08, shall certify and deliver a copy of this Resolution by hand or via certified U.S. Mail, or by electronic delivery, to the Registrar of Motor Vehicles at the Ohio Bureau of Motor Vehicles on or before July 1, 2024 at the following address:
