- Costs are less than 2025, but there are no culverts listed.
- Need to add Calhoun Road from 2025 that did not get completed. That cost will be roughly \$50,000.

2026 BUDGET DISCUSSION

- Culverts
 - OPWC grant work contains 2 culverts that will need replaced. Tyler Road and Brown Road. Both are 12” culverts and will cost \$20,000 each
 - Culvert on Shipley Road south of Slocum. This one is a bigger culvert and cost of \$25,000.


Trustee Loudenslager will be out of town December 12 through December 20.





Meeting adjourned at 5:25pm.







