RECORDING OF PROCEEDINGS  
March 17, 2020**

**REGULAR MEETING PROCEEDINGS SUMMARY:**

The trustees of Scioto Township met in regular session, Wednesday, March 17, 2020 at 5:30 pm at the Scioto Township Community Center, 3737 Ostrander Road, Ostrander, Ohio 43061. Board members present were Ralph Moseley, Sandra Stults, and Doug Loudenslager. Also present was Chief McIntire and Fiscal Officer, Kathy Melvin. Others in attendance are listed on the attached sign-in sheet.

The trustees appreciated all submitted bids.

Trustee Stults made a motion to accept the cemetery bid request from Property Worx for \$837.11 a mow. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-abstain, Mr. Moseley-yes and Ms. Stults-yes. The motion passed with 2-yes and 1-abstention vote.

Trustee Stults made a motion to accept final appropriations submitted by Fiscal Officer. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults made a motion to close the township hall for meetings/gatherings for the through April and trustees will revisit the closure at the end of April. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Moseley made a motion for Fiscal Officer to have cleaning crew perform a deep clean and sanitation to the entire building. The motion was seconded by Trustee Stults. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Loudenslager made a motion to hold the trustee meetings through “goto meeting.com” for April. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults made a motion to pay bills. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Doug Riedel provided the trustees with the wording from the speed limit change for Jacktown Road that could be used for Russell Road.

Doug Riedel also stated if the township needed help with road or maintenance, they would be available if our employees were not able.
