RECORDING OF PROCEEDINGS  
October 15, 2020**

**REGULAR MEETING PROCEEDINGS SUMMARY:**

The trustees of Scioto Township met in regular session, Thursday, October 15, 2020 at 5:30 pm via GoToMeeting.com. Board members present were Doug Loudenslager, Ralph Moseley, Sandra Stults, and Chief McIntire.

Trustee Moseley made a motion for monument repairs in Millcreek cemetery for the cost of \$2,900 to Longstreth Wilbert. The motion was seconded by Trustee Stults. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults made a motion to adopt Resolution to report coronavirus relief funds for the period of March 1, 2020 through September 30, 2020. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults made a motion to adopt Resolution to appoint Delaware County United Way as a sub recipient of coronavirus relief funds to meet the needs of the community due to Covid-19. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes

Trustee Moseley made a motion to purchase 500 bottles of hand sanitizer at \$4.00/each not to exceed \$2000. The motion was seconded by Trustee Stults. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes
