Board members present were Ralph Moseley, Sandra Stults and Doug Loudenslager. Also present was Chief Marvin McIntire. Fiscal Officer Kathy Melvin was absent. AWARD PARK BALL DIAMOND

Trustee Loudenslager moved to award the park ball diamond bid to Schubert Tennis not to exceed \$93,759. The motion was seconded by Trustee Stults. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

He also addressed changes in the pay structure for volunteer firefighters. The Trustees will be considering placing a replacement levy on the November ballot.
